2023 Summer Dockage charges \$220	.00 x   ft = \$	due.
Contract term is from May 15 <sup>th</sup> through October 15 <sup>th</sup> of the contract year. Summer dockage runs concurrent to these dates and vessels may not be brought in from outside the marina until May 15 <sup>th</sup> , and must be removed from the marina prior to October 15 <sup>th</sup> of the contract year. All vessel electric use is metered and billed on regular intervals, no exceptions. Payment and contract should be sent to the main office with a 25% non-refundable deposit by October 31 <sup>st</sup> 2022, 25% more by Jan 31 2023, and the final 50% by March 31 <sup>st</sup> of the current contract year.  ***** Slips will be sold to to wait list customers in November 2023 and not be available if you do not make the initial 25% payment in October.*****		
The word "Marina" is used to indicate any person authorized to represent Pointview Marina. The word "Tenant" is used to		
indicate the owner (or his authorized representative) of any boat moored at Pointview Marina.		
This Agreement shall be in effect, unless sooner terminated in accordance with the following conditions, to wit:  a. By destruction of the dockage facilities by fire, storm or other calamity.		
b. In the event the tenant shall make a bona fide sale of the boat listed in his agreement.		
c. By breach or default as provided in paragraph below.		
Tenant agrees to comply with all rules and regulations on the reverse side, as fully as though they were set forth herein, and should breach of this agreement or violation of rules and regulations occur, this rental agreement shall terminate immediately at the sole opinion of the Marina and the Marina may remove the boat from her mooring space at the Tenant's risk and expense and retake possession of the mooring space.  Waiver of any conditions by the Marina shall not be deemed to be a continuing waiver.
